A New Year Means a New Process for Shopping

New Year, New Website

2024 is the year we will implement our new Website. The newly redesigned harc-ct.org site will have enhanced security features, intuitive organization, including a new navigation pane and search feature, shopping options from Harc logoed swag to Artisan Studio Gifts and Sockstarz, event registration, a staff training portal and advanced accessibility features. It is expected to launch mid-year.

Are you curious about how stuff like this comes to fruition?

In order to get a new website, we created an RFP or Request for Proposals. It's a document that outlines what we want to see in our new website and provides details about all the new features and functions we want and how much we are willing to pay for it and provides a timeline to explain when we need each phase of the project completed by. Then website creating companies can choose to submit a proposal. If we like their proposal and select them to do the work they commence and are expected to meet the milestones and ultimate deadline.

Are you curious about how a project like this gets funded?

One part of the American Rescue Plan Act of 2023 allocated funding, to nonprofits like us, for technology improvements. Like all the funding we receive, there are specific types of purchases the moneys can be used for and thankfully a website redesign is one of them.

A Note from the Finance and Administration Office

W2s, W4s, and More

It's tax time! W2s were mailed to all employees early in January. If you need to obtain a copy. you can do so from ADP. Once you log in to ADP, click "Myself," then under "Pay" click on "Pay & Tax Statements," then in the section "Tax Statements" click "View Statement." Now is also a good time to think about updating your W4 if you need to change your tax withholdings. This is really important to do if you had a change to your marital status or number of dependents in 2023. To update your W4, log in to ADP then click "Myself," then under "Pay" click on "Tax Withholdings," then click "start." You can update your W4 at any time during the year. For our Birth to Three contractors, 1099-NECs were mailed mid-January. If you do not receive a copy by the end of January you can contact the business office to obtain a copy.

Now is also a good time to consider updating your retirement contributions. This can also be done via ADP. Click "Myself," then under "Benefits" click on "Retirement Savings," then in the section "Contributions" click "Edit Contributions." Our plan allows for either a percentage of pay or a set dollar contribution each pay period.
